DATE: October 11, 2018
SUBJECT: Tourist Development Tax (TDT) Collections

RECOMMENDATION:

That the Board accepts, for filing with the Board's Minutes, the Tourist Development Tax (TDT) Collections Data for the August 2018 returns received in the month of September 2018, as prepared by the Finance Department of the Clerk and Comptroller's Office. This is the twelfth month of collections for the fiscal year 2018.

- ✓ Total collected for the month of August 2018 returns was \$1,104,183.46. This is a 14.13% increase over July 2017 returns.
- ✓ Total collections year to date are 7.20% more than the comparable time frame in Fiscal Year 2017.

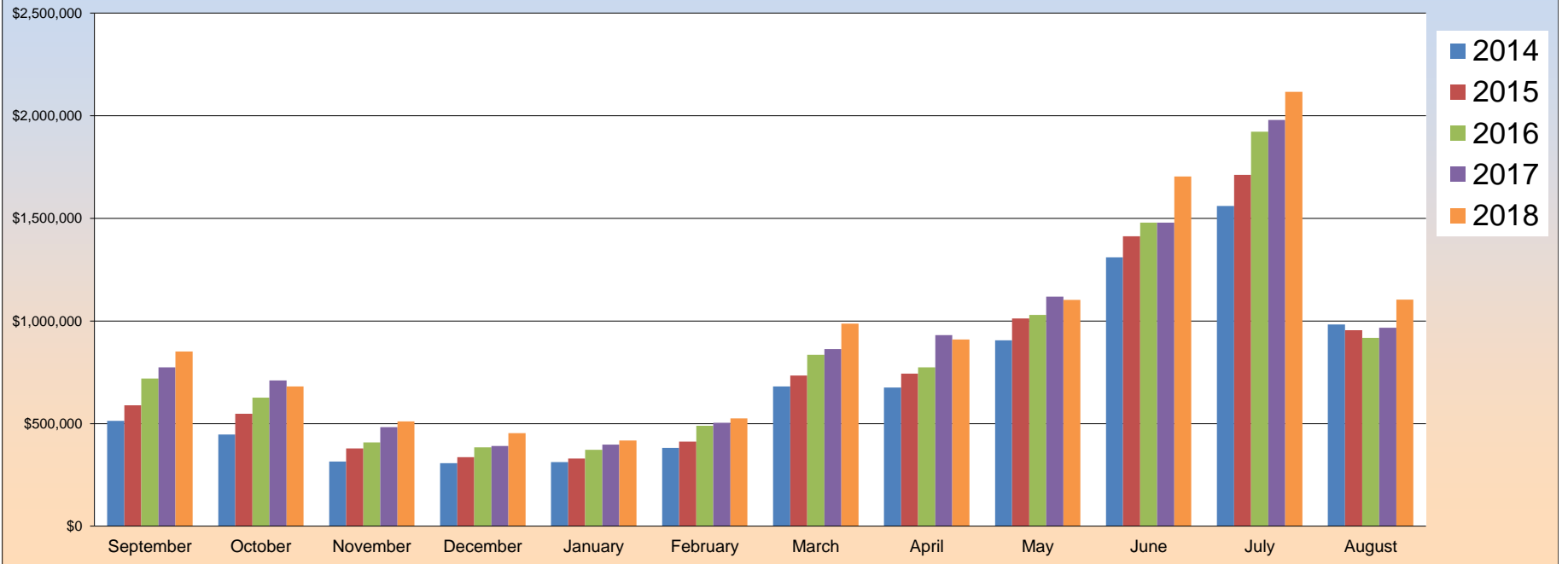

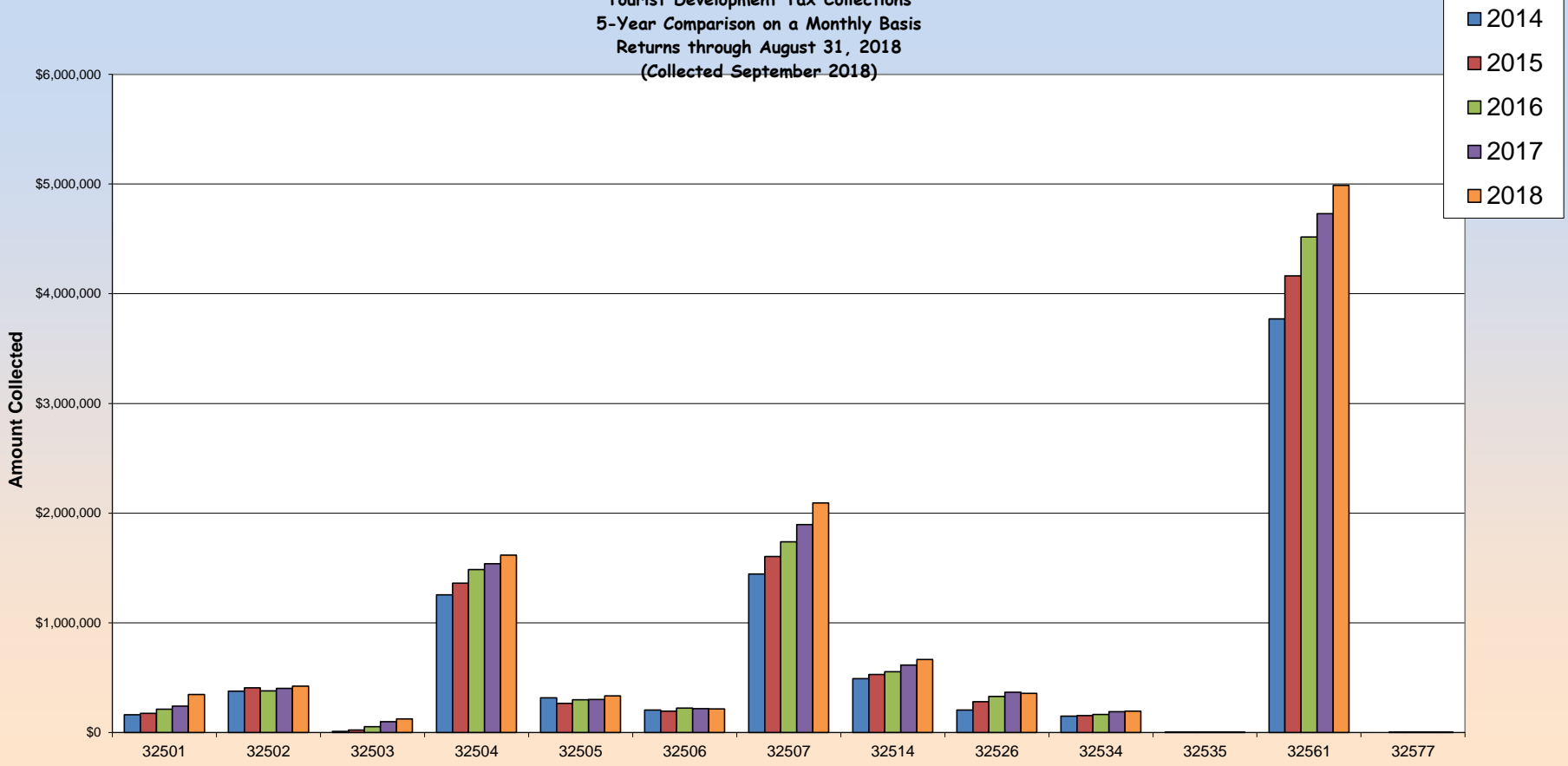

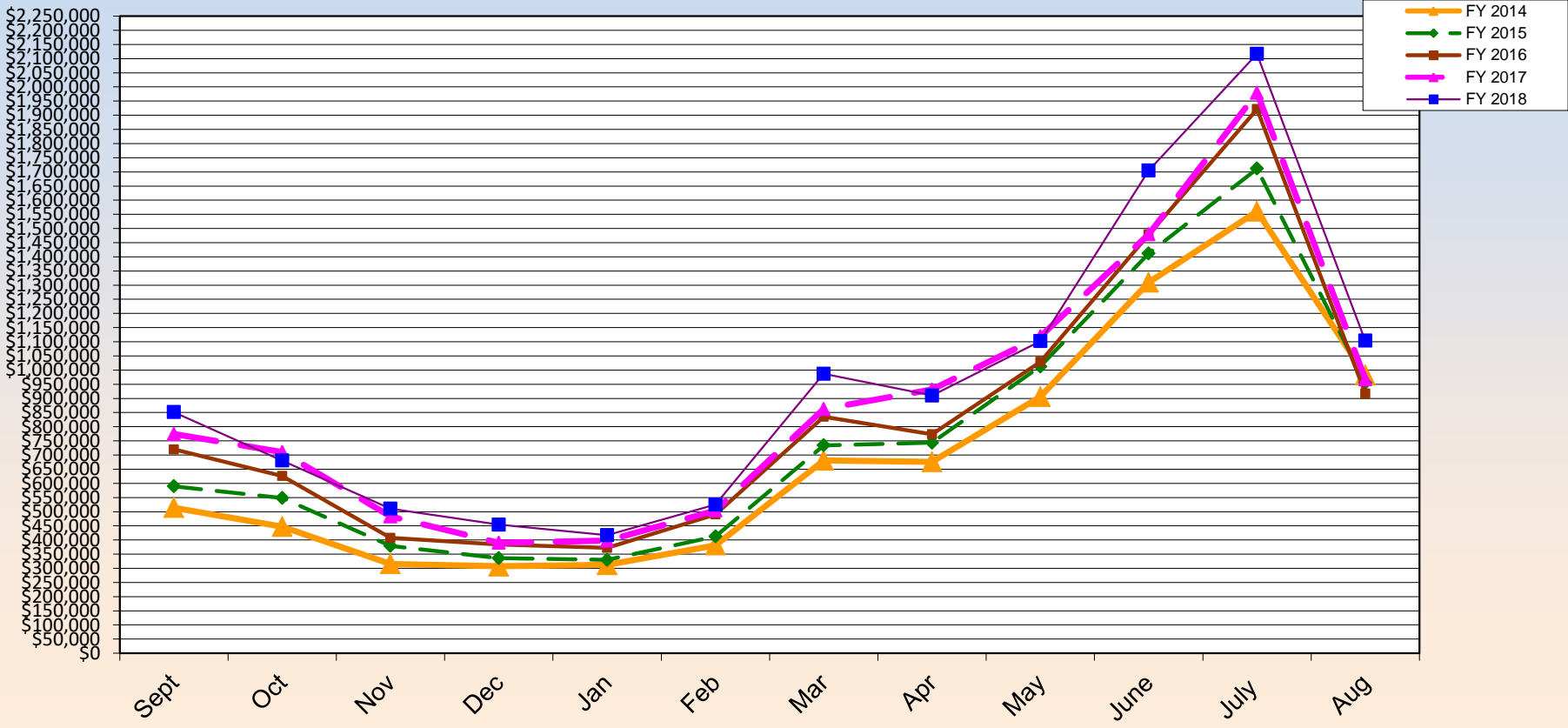
Tourist Development Tax Collections
